# European Mobility Programme «internship@worldclasslab»

### Description of the call for mobility

This action aims to allow ten (10) students from the Master program "AI&Health" within the scope of European project AI&Health to realize their 6 months intership in the works-class labs of Inria (French Research Institute for Computer sciences). The action must contribute to the training advancement with the additional expertise of Inria teams hosting the student. The goal is to recognize and reward academic excellence and encourage students to make the most of their studies.

#### Funding modality

The principles and procedure for awarding funding: this call is open only for students from EU-countries, EFTA countries, and those from countries already associated with the Digital Europe program (like Ukraine). Applicants need to be registered as students in the Master's program AI for Health. Please note that this scholarship cannot be combined with other European-funded grants (e.g., the allowance awarded as part of the mobility for traineeship within the Programme Erasmus+) to avoid double-funding.

The funding of the student mobility action takes place as the financial support (600 euros/month). Supported expenses correspond to the eligible expenses according to the EC funding rules, namely travel expenses between the place of residence and the host laboratory. There expenses don't cover accommodation and meals. Repatriation insurance and necessary liability insurance are not covered.

## **Hosting Contract**

A hosting contract must be signed between Inria and the partner University prior to the departure of the student stipulating the conditions of access to the laboratory, and the management of the intellectual property generated during the internship. Inria legal department will provide support for the establishment and signing of these hosting contracts, except in specific cases.



## Calendar of internship

- November 21, 2025 : Call for mobility opening
- December 5, 2025 : Call for mobility closing
- December 12, 2025 : Evaluation process and notifications to Europeans laureates<sup>1</sup> and Internship contracting
- January 2026 : Staring the internships
- June 2026 : End of internship

## Application and submission process

Interested students must submit their application in English, including the following documents:

- A cover letter explaining the motivation for applying and how the grant would be used for (e.g., covering fees, travel for student exchanges, accommodation, living costs or other uses)
- A transcript of courses taken and the grades received per course so far per 2025-06-30
- Explanation for any missed courses or low grades
- Brief CV
- A copy of the applicant's passport

#### Selection criteria

Grants will be awarded based on academic excellence, considering the number of courses and credits completed, grades achieved, and the strength of the motivation letter.

In the event of a tie between applicants, preference will be given to those who provide a clear and compelling explanation of why they apply for this grant and how they intend to use the grant.

#### Further information

- **Payment arrangements**: Grants will be paid directly by Inria to the selected students, approximately 2 weeks after the official decision, and after Inria has received the successful applicants' bank account details.
- Maximum budget of this call: 36 000 Euros
- Grant amount: 3 000 Euros per individual grant recipient.
